When you are entering your print/slide title onto the register that color slide/print chairman provides, please not only print clearly but put the whole title of the slide/print. I work from the register putting the titles on the score sheet that is to be provided to the judge to write comments. I compare the titles typed in with the slides or prints after putting the information onto the score sheets and sometimes have shut down the program only to find out that someone did not write the full name in or wasn't written clearly. It delays in getting the items ready to be delivered or mailed as I have to redo almost everything to match.

When you mount your photos please, if at all possible, do not use black or real dark backgrounds where title etc. are located. Please use the lighter side of the board as the stamp for placing date and score is sucked up and can't be read or barely so.

Also, when placing your slides or prints be sure to see that you put them into the correct container, b&w into b&w, color prints with color prints, and the color slides into the color slides container, not color slide return container or nature container and visa versa as it could cost you points as they weren't entered if you put them in error in the nature division container.
